ORDER GRANTING THE APPLICATION OF THE OFFICIAL COMMITTEE OF UNSECURED CREDITORS OF LANDAMERICA 1031 EXCHANGE SERVICES, INC. FOR AN ORDER AUTHORIZING THE EMPLOYMENT AND RETENTION OF PROTIVITI, INC. AS FINANCIAL ADVISOR

Upon the application (the “Application”) of the Official Committee of Unsecured Creditors of LandAmerica 1031 Exchange Services, Inc. (the “LES Committee”) for an order authorizing the employment and retention of Protiviti, Inc. (“Protiviti”) as financial advisor, and the Verified Statement of Guy A. Davis in support of the Application (the “Affidavit”), and the Court being satisfied with the representations made in the Application and the Affidavit that Protiviti represents no interest adverse to the estates of LandAmerica 1031 Exchange Services, Inc. and LandAmerica Financial Group, Inc. (collectively, the “Debtors”); and it appearing that Protiviti is a disinterested person as that term is defined under Section 101(14) of title 11 of the United States Code (the “Bankruptcy Code”), that Protiviti’s employment is necessary and would be in the best interests of the Debtors’ estates; and it appearing that proper and adequate notice has been given and that no other or further notice is necessary; and after due deliberation thereon; and good and sufficient cause appearing, therefore, it is ORDERED, ADJUDGED, AND DECREED, that:

1. The Application is granted.
2. In accordance with Bankruptcy Code Sections 105, 327, 328, 336, 1102, 1103, and 504, and rules 2014, 2016, and 5002 of the Federal Rules of Bankruptcy Procedure (the “Bankruptcy Rules”), the LES Committee is authorized to employ and retain Protiviti as financial advisor to the LES Committee effective as of December 12, 2008 on the terms set forth in the Application and Exhibit A thereto.

3. Protiviti shall be entitled to allowance of compensation and reimbursement of expenses upon the filing and approval of interim and final applications pursuant to the Bankruptcy Rules, the local rules of this Court, the order granting the Debtors' Motion for Administrative Order Under Section 105(a) and 331 of the Bankruptcy Code Establishing Interim Compensation Procedures, and such other orders as the Court may direct; and, subject to compliance with the foregoing, the Debtors shall pay to Protiviti the monthly fees and expenses.
